Project Measures:

The Services requested under this assignment will be implemented and tendered in three separate Lots (subject of this tender). Applicants are invited to apply for one or several Lots.

The aim of the GCFI is to assist the Republic of Iraq in its efforts to support the return of internally displaced persons (IDP) and by these means to contribute to the stabilization of the country. This shall be reached through investments and the swift reconstruction of degraded basic infrastructure in the territories liberated from the so-called "Islamic State" in the provinces of Al-Anbar, Diyala, Niniveh and Salah-Al-Deen, i.a. in the health sector.

To this end a detailed Feasibility Study (FS) of several health facilities has been undertaken.

The Feasibility Study included the assessment of the interdisciplinary Nursing Home Special Hospital (NHSH) Baghdad. The rehabilitation of the NHSH are now to be implemented under the Project. (Lot 1)

The FS also covered two general hospitals in liberated stable governorates with large numbers of returning IDP being Haditha Hospital in Al Anbar Governorate and Al Dour Hospital in Salah Al Deen Governorate. At both hospital sites construction works had been halted but, as a result of the FS, works are now to be resumed and completed under the Project. (Lot 2)

The design and construction of a Health Care Facility in Mosul Governorate will be included in the Project. (Lot 3). The exact location is yet to be defined. Through Project funding following main components shall be implemented:

Requested Consultant Services:

Services are to be provided by a consulting firm or consortium, offering a team of sector-and subject-related experienced international and national experts. The firm shall fulfil its tasks and services largely in the Iraq. The nominated team leader will be responsible for ensuring a well-planned, coordinated and effective internal and external interaction with all concerned participants in order to ensure a timely and successful elaboration of services. The team of international and local staff shall comprise expertise in Public health and hospital management, hospital planning and architecture incl. necessary engineering expertise of infrastructural supply technology, ESIA expertise, procurement of medical equipment, hospital business planning. Apart from technical qualifications, key staff should have adequate experiences in regional, social and other non-technical issues.

The start of the consulting services for all three Lots is planned for the first quarter of 2021, however the individual Lots may also start independently from each other based on their readiness. The planned duration of each Lot is approx. 36 months.

Consultants have to be aware that due to the particular situation in the Iraq, special requirements and regulations for safety and security of consultants and contractors of KfW in high risk areas apply.

The prequalification procedure of experienced Consultants will follow the KfW "Guidelines for Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partner Countries", which are available on KfW's internet web-site (version January 2019):

It is foreseen to award the service to an internationally operating consulting firm, preferably in association with domestic consultants, which are highly experienced in the concerned fields with an average annual turnover of the lead consultant and all associated partners showing the necessary turnover for the consortium as a group of at least EUR 5.0 million (Lot 1), EUR 7.5 million (Lot 2) and EUR 3.5 million (Lot 3).
